## How to Earn Entries:

- Participants must swipe-in between 1:00 pm-4:10 pm on Wednesday, March 1, 8, 15 \& 22, 2017 to be eligible for that day's drawings
- All players will receive one free entry on Mondays \& Tuesdays by swiping at the kiosk. Maximum three entries


## Rules:

2. Participants must swipe-in between 1:00 pm-4:10 pm before any of the drawings on Wednesday, March 1, 8, 15 \& 22, 2017. (Only one swipe required per drawing day. No points required to swipe in entries.)
3. Drawings will take place at the designated area (see Rampart Rewards Club for details).
4. Customer must be present to win. Guests have three minutes to claim their prize.
5. Patrons must earn 250 same day base points to earn free entries on Monday and Tuesday into each drawing on March 1, 8,15 \& 22, 2017.
