\$250,000 Balloon Bucks Drawing Official Rules

Promotion Period: 3 am January 26, 2019 thru 8:15 pm February 23, 2019

Drawings Friday & Saturday, February 1, 2, 8, 9, 15, 16, 22 & 23 at 6:15 pm & 8:15 pm

Winner Breakdown:

5 Winners at each drawing at 6:15 pm & 8:15 pm

How to Earn Entries:

- Guests earn one kiosk entry for every 100 points earned on Slots or Bingo
- Customers earn one kiosk entry for one hour of play at \$10 average bet or equivalent on Table Games
- Customers earn 10X entries from Monday-Thursday each week.
- Bonus entries will be awarded through mailers and kiosk promotions.

Rules:

- 1. Participants must have a Rampart Rewards card and be at least 21 years of age to participate. Guests without a card can sign up at the Rampart Rewards Club for free.
- 2. Participants must swipe-in between 3:00 pm and 6:10 pm on Friday & Saturday for the 6:15 pm drawing or between 6:30 pm and 8:10 pm for the 8:15 pm drawing. (Only one swipe required per day. No points required to swipe in entries.)
- 3. Participants who check into the drawing without entries are not eligible to win.
- 4. Drawings will take place at the designated area (see Rampart Rewards Club for details.)
- 5. Customer must be present to win. Guests have three minutes to claim their prize.
- 6. Starting January 26, 2019 at 3 am, patrons will start earning entries into the drawing for every 100 base points earned each day playing slots or Bingo and for \$10 average bet or equivalent on table games.
- 7. Automated drawing entries are non-transferable.
- 8. Drawings will be held on February 1, 2, 8, 9, 15, 16, 22 & 23, 2019.
- 9. At each Friday and Saturday drawing at 6:15 pm and 8:15 pm, five (5) winners will be drawn. There will be a digital screen where guests get to pop balloons.
- 10. Guests will have a predetermined time limit to pop balloons on the screen.
- 11. Prizes will be issued based on balloons popped.
- 12. Prize will be determined by adding together each amount of popped balloon.
- 13. Each winner will restart at the beginning of the game and all will have the same time allotted.
- 14. \$250,000 Prize is insured by a third party.
- 15. Customers can choose prize in cash, free slot play or promotional chips for any prize of \$2,500 or less.
- 16. Although this promotion is called \$250,000 Balloon Bucks Drawing, the actual amount of prize consideration awarded may exceed, equal, or be less than \$250,000, and the actual amount of prize consideration awarded will be determined randomly by the cumulative outcome of each winning contestant's draw from the prize boards.
- 17. All winners must show their Rampart Rewards Club card and have valid identification to be verified.
- 18. Participants can only be drawn once per drawing night.
- 19. The drawing barrel will be emptied after the 8:15 pm drawing on February 23, 2019. All player drawing entries will re-set at zero at this time.
- 20. In case of a public address system failure, the drawing continues on site manually. Management urges quests to be in or around the drawing area.
- 21. By participating in this promotion, winners hereby give their permission to Rampart Casino and any of its affiliated companies to use their names or likeness etc. for promotional purposes without compensation.

- 23. Winners must have valid identification and Social Security number. If winner doesn't present valid identification and Social Security number upon winning then the casino cage will hold the prize for 48 hours. If not claimed within that time the winner forfeits the prize.
