Pirates Treasure Progressive Drawing Official Rules

Promotion Date: Last Wednesday of Each Month at 6:15 pm & 8:15 pm
Promotion Start: January 1, 2018-ongoing

How to Earn an Entry:

- Earn 2,000 base points in the previous month for one entry into the following month's drawing. For example, earn 2,000 base points in December for an entry into January's Drawing.
- Invited guests will receive an entry into the drawing at the end of each month.

Rules:

1. Participants must have a Rampart Rewards Club card and be at least 21 years of age to participate. Guests without a card can sign up at the Rampart Rewards Club for free.
2. Participants must swipe-in after 3 pm and before any of the drawings on the last Wednesday of each month. (Only one swipe required per day. No points required to swipe in entries.)
3. Participants who check into the drawing without entries are not eligible to win.
4. Drawings will take place at the designated area (see Rampart Rewards Club for details).
5. Entries for progressive drawings should be earned the month prior to the actual drawing month. Example: Earn entry from March 1 through March 31 to qualify for April's last Wednesday of the month drawing.
5. Players will only receive one entry for the drawing. To qualify for an entry, patrons must earn 2,000 base points in the previous month.
7. Player's must activate their entry at the kiosk after 3 pm on the last Wednesday of the month to activate their entry. Drawings will be held promptly at 6:15 pm & 8:15 pm.
8. 20 winners are guaranteed their choice of cash, free slot play or promotional chips.
9. Ten (10) winners will be drawn at 6:15 pm and ten (10) winners will be drawn at 8:15 pm.
10. Cash prizes range from \$250 to the progressive amount for that month.

12. There is no limit to how high the progressive can grow.
13. The progressive prize goes up \$1,000 each month if unclaimed and re-sets at \$5,000 when the progressive is hit.
14. Customer must be present to win. Guests have three (3) minutes to claim their prize.
15. Automated drawing entries are non-transferable.
16. All winners must show their Rampart Rewards Club card and have valid ID to be verified.

18. The drawing barrel will be emptied after the last drawing of the month. All player drawing entries will re-set at zero at this time.
