**Winner Breakdown:** Five winners at each drawing at 4:15 pm & 6:15 pm. 30 total winners.

### Free Slot Play Prize Breakdown:

5 – \$75 (FSP) 6 – \$100 (FSP) 3 – \$150 (FSP)

#### **Cash Prize Breakdown:**

4-\$100 | 3-\$150 | 2-\$250 | 1-\$500 | 1-\$1,000

#### **How to Earn Entries:**

- Earn 250 points on Thursday, June 7, 14 & 21, 2018
- Participants must swipe-in between 1:00 pm-6:15 pm on Thursday, June 7, 14 & 21, 2018 to be eligible for that day's drawings
- All players will receive one free entry on Mondays, Tuesdays and Wednesdays by swiping at the kiosk. Maximum three entries

#### **Rules:**

- 1. Participants must have a Rampart Rewards Club card and be at least 21 years of age to participate. Guests without a card can sign up at the Rampart Rewards Club for Free.
- 2. Participants must swipe-in between 1:00 pm-6:15 pm before any of the drawings on Thursday, June 7, 14 & 21, 2018. (Only one swipe required per drawing day. No points required to swipe in entries.)
- 3. Drawings will take place at the designated area (see Rampart Rewards Club for details).
- 4. Customer must be present to win. Guests have three minutes to claim their prize.
- 5. Patrons must earn 250 same day base points to earn entry on Thursday. Free entries will be provided for swiping your card on Monday, Tuesday, and Wednesday into each drawing on June 7, 14 & 21, 2018.
- 6. Automated drawing entries are non-transferable.
- 7. At each Thursday drawing at 4:15 pm and 6:15 pm, five winners will be drawn. There will be 25 spots on the wheel. The player will spin the wheel three times. - 8. All winners must show their Rampart Rewards Club card and have valid identification to be verified.
