- Guests earn one (1) kiosk entry for every 100 points earned on slots or Bingo

### Qualifying Drawings

1. Qualifying drawings will be held on Friday and Saturday Nights throughout the promotional period at 6:15 pm and 8:15 pm. Drawings will be held on August 31, September 1, 7, 8, 14, 15, 21, 22, 28 & 29, 2018. Seven (7) winners will be drawn each hour.
2. Each qualifying winner will draw off the Prize Board. The Prize Board will start with 100 prize pieces each night. The winners will pick between \$250 Free Slot Play and \$2,000 Cash. The prize board will be re-set before each drawing.

### Grand Prize Drawings

5. The Grand Prize Car Drawings will be held on September 28 & 29, 2018 at 9:15 pm.
