Promotion Period: 3am, February 27, 2021 thru 10pm, March 27, 2021

How to Earn Drawing Entries

One entry per:

- Customers earn one kiosk entry for every one hour of play at \$10 average or equivalent on Table Games
- Customers earn 2X entries from Sunday-Friday each week
- Bonus entries will be awarded through mailers and kiosk promotions

Envelope Breakdown for the 9 pm & 10 pm Drawings:

- One (1) \$1,000 = \$1,000 Cash
- Four (4)\$500 = \$2,000 Promotional Chips
- Five (5).....\$200 = \$1,000 Promotional Chips
- One (1) 2X Multiplier
