### Winner Breakdown:

- 5 Winners at each drawing at 6:15 pm & 8:15 pm

### How to Earn Entries:

- Customers earn one drawing entry for every 100 points earned on Slots or Bingo
- Customers earn one drawing entry for one hour of play at \$10 average bet or equivalent on Table Games
- Customers earn 10X entries from Monday-Thursday each week.
- Bonus entries will be awarded through mailers and kiosk promotions.

### Rules:

1. Participants must have a Rampart Rewards card and be at least 21 years of age to participate. Guests without a card can sign up at the Rampart Rewards Club for free.
2. Participants must swipe-in between 3:00 pm and 8:10 pm on Friday and Saturday for the 6:15 pm & 8:15 pm drawings. (Only one swipe required per day. No points required to swipe in entries.)
3. Participants who check into the drawing without entries are not eligible to win.
4. Drawings will take place at the designated area (see Rampart Rewards Club for details.)
5. Must be present to win. Guests have three (3) minutes to claim their prize.
6. Starting May 1, 2021 at 3:00 am, patrons will start earning entries into the drawing for every 100 base points earned each day playing slots, bingo, and one drawing entry for one hour of play at \$10 average or equivalent on Table Games..
7. Automated drawing entries are non-transferable.
8. Drawings will be held on May 7, 8, 14, 15, 21, 22, 28 & 29, 2021.
9. At each Friday and Saturday drawing at 6:15 pm & 8:15 pm, five (5) winners will be drawn. There will be one prize board with 20 envelopes. The guest must pick five envelopes to make the best five (5) card poker hand possible. Payouts will be:
