#### Rules

#### Weekly Slot Tournament Rules:

- a. All guests will receive one round each week. Patrons must swipe at the MGT kiosks located on the casino floor for a ticket between 9 am and 6:45 pm to be eligible. The ticket will grant them entrance into the tournament.
- b. Earn another entry for 500 points.
- c. Weekly prizes will be awarded for each weekly Wednesday Tournament. See Prize Breakdown above for each week's prizes.
- d. Daily tournaments begin at 11 am and end at 7 pm. We will continue the tournament past 7 pm if we have the need for additional rounds for anyone who signs up by 6:45 pm.
